鄧志雄，中南大學有色冶煉專業畢業，中共中央黨校經濟管理專業研究生、中青班第十期學員，教授級高級工程師，中國人民大學、中山大學、中國政法大學、中國大連高級經理學院特聘教授，深創投博士後流動工作站導師。曾任湖南新晃汞礦礦長、上市公司海南金海股份公司董事長，中國有色金屬工業總公司計劃部副主任，國家有色金屬工業局企事業改革司司長，國家經貿委綜合司副司長，國務院國資委產權管理局局長和規劃發展局局長，中國電信、中國鋁業、中國保利集團專職外部董事。

現任中國航天科工集團、中國中化控股集團兼職外部董事。對中央企業改革發展戰略、國有企業現代治理制度與機制、企業國有產權市場化形成運營與流轉、中國式複合資本市場建設、世界經濟危機的企業制度成因分析與應對、混合所有制經濟發展的理由和方式、以數學為依據用和差與積原理研究解決社會科學問題，均有獨到的見解。

Mr. Deng Zhixiong graduated from the Department of Metallurgy at the Central South University, majoring in nonferrous smelting. He is a graduate student of economics and management and a participant of the 10th intake of the class for young-to-middle-aged participants at the Party School of the Central Committee of the Communist Party of China, and a senior engineer of professorial grade. He is also a distinguished professor at various tertiary institutions including Renmin University of China, the China University of Political Science and Law, Sun Yat-sen University, and the China Business Executives Academy, Dalian. He is a supervisor at the post-doctoral research station of Shenzhen Capital Group Company Limited.

Mr. Deng was the director of Xinhuang Mercury Mine of Hunan province and a director of the listed Hainan Jinhai Co. Ltd. He has served as a deputy director of the Planning Department at the China Nonferrous Metals Industry Corporation, the director of the Office of Corporate Reform at the National Nonferrous Metals Industry Bureau, a deputy director of the General Affairs Department of the State Economic and Trade Commission, and the director of the Bureau of Property Right Management and the Bureau of Planning and Development of the State-owned Assets Supervision and Administration Commission of the State Council. He was a full-time outside director at several major corporations, including China Telecom, Aluminum Corporation of China Limited and China Poly Group Corporation Limited.

Mr. Deng is currently a part-time outside director at China Aerospace Science and Industry Corporation Limited and Sinochem Group Company Limited. He is an expert on the corporate reform of state-owned enterprises and has specialised in the application of mathematical tools in solving social problems in a scientific way.
