- Credit transfer is not eligible for PG students.






Preparation work for Year 1 and Year 2 students

- > Engage in better planning for your study plan.











 - Check your study planRisks of credit transfer

 - Not a reason for withdrawal

Tuition fees

• Students shall pay tuition fees to UM while the tuition fees at Partner school will be waived.

> Other expenses

• Students are responsible for their own financial support for the exchange, including but not limited to accommodation, transportation, insurance and visa, etc.

 Notify your parents about your exchange
As you may have limited time to make your decision. It is important to have a conversation with them in advance to discuss the details and gather their input.

How can you Apply?

✓ Application System

- Applications should be make via the "Outbound Exchange and Scholarship Application System" (website: <u>https://isw.um.edu.mo/seas</u>);
- ✓ Period: 09th Jan ~ 22nd Jan, 2025
- ✓ Follow the instructions in website and fill out all required documents, upload into the system.
- ✓ Make sure you read through the credit transfer requirement
- ✓ Submit Learning Agreement (Part 3 of FBA website) BEFORE exchange and Course Exemption Application (Part 4 of FBA website) AFTER exchange
